MANDATORY MEETING:

There will be a **mandatory workshop/** press conference for the **HEAD** wrestling coach or an appointed representative from their school on **Monday, November 7, 2011**, at 5:00PM, at the WesBanco Arena in Wheeling, WV. The mandatory workshop will begin promptly at 5:00PM, followed by the wrestling press conference at 6:30PM. Any school not in attendance will have to pay a \$100 penalty **AND** attend a make-up meeting or they will be ineligible for the season.

GUIDELINES:

1. Teams must commit to compete and sign a contract by March 31 of the previous year. Teams choosing not to participate will also be ineligible to participate the following year. [**NOTE:** This rule will be waived for the 2012 season only.]

2. Each team must have wrestled **AT LEAST THREE (3) OVAC schools** prior to the Ron Mauck Wrestling Tournament in January. All results must be received by midnight of the Wednesday prior to the Ron Mauck Wrestling Tournament.

3. In order to be eligible for the Dual Meet Championship, each team must have **AT LEAST SIX (6) wrestlers** compete at the Ron Mauck Wrestling Tournament. "Compete" is defined as wrestling at least one (1) match.

4. If a team commits to compete by March 31 and then does not have enough wrestlers compete in the Ron Mauck Wrestling Tournament, the penalty in #1 will not apply.

5. The first round will be a dual, tri, or super tri on the second Wednesday after the Ron Mauck Wrestling Tournament (**February 1, 2012**). The sites will be determined by the OVAC Wrestling Committee and announced by April 30 of the year prior to the event.

6. The Dual Meet Championships will be held on the third Wednesday (**February 8, 2012**) after the Ron Mauck Wrestling Tournament at WesBanco Arena in Wheeling, WV.

*The Dual Meet Championship format will go into effect for the 2011-2012 season.

APPLYING FOR A FIRST ROUND SITE:

Schools interested in hosting the first round matches for their class must apply by March 31 each year and must be able to provide the following:

- At least three (3) mats in your gymnasium;
- At least three (3) clocks viewable by the spectators and the coaches;
- Team scores visible to spectators and coaches for each mat;
- A clock/score operator and a tapper for each mat;
- A concession stand;
- Required number of officials as determined by the Wrestling Committee;
- Ticket takers, security, and any other workers. (Trainers will be provided by the OVAC unless the host school has their own).

A financial report must be completed and submitted to the Championship Director after the First Round and before the Championship. A form will be provided to the host school.

The host school will be responsible for all profits and losses.
